2023 Physician Fee Schedule Changes



The Centers for Medicare & Medicaid Services (CMS) released their Final Rule for the 2023 Physician Fee Schedule (PFS) in the *Federal Register* on November 18, 2022, and an updated 2023 Medicare conversion factor on January 5, 2023. The final rule includes revised evaluation and management (E&M) coding guidelines that are intended to reduce administrative burden, primarily in inpatient settings and skilled nursing facilities. These changes will further impact E&M CPT code documentation requirements, wRVU values, and resulting wRVU production levels for physicians and advanced practice providers (APPs) providing these services in inpatient and skilled nursing facility settings.

CMS has reduced its Medicare Conversion Factor to \$33.89


(a 2.1% decrease from the 2022 Medicare conversion factor of \$34.61)

- Some observation codes have been removed (99224 – 99226)
- Home/residence service wRVU values have also been revised
- The time requirements for various codes have changed (99233 was 35 minutes and will be 50 minutes)

SullivanCotter conducted an assessment of the 2023 Final Rule to help organizations anticipate reported wRVU changes by specialty:



Projected Impact of 2023 Final Rule on Reported wRVUs



- The 2023 Final Rule will increase reported wRVUs for specialties providing inpatient and skilled nursing care
- The Medicare conversion factor decreases will reduce Medicare reimbursement for other specialties
- Reimbursement and wRVU values have increased for immunization administration, impacting pediatric physicians and APPs due to the high volume of immunizations they administer
- CMS has delayed the implementation of the changes related to Split/Shared Visits until January 1, 2024
